4. In case your rates are accepted, then you have to deliver the sample furniture within 7 days and if your sample is approved by the Accepting Officer, you have to deliver the furniture within 30 days from the date of this work order failing which work order is liable to be cancelled.

5. After delivery, all the furniture which is received will be inspected by the board of officers and matched with the sample. Delivery will be accepted only if the order is found correct otherwise the order will be cancelled and returned without any payment. In case of any discrepancy, decision of Chairman, Army Public School hempur will be final.

6. Cost of Tender is Rs 500/- (Rupees five hundred only) non refundable to be deposit at school office at the time of submission of tender.

7. Please note that your quotation will be subject to your general conditions given below. The conditions being part of this enquiry list should be read carefully before submission of your quotation.
